Durham Connect provides collaborative mobilization of resources and services in order to mitigate acutely elevated risk and reduce imminent harm from occurring to individuals or families living in Durham Region.

Risk factors may include, but are not limited to;

-Addiction -Physical health

-Homelessness -Flder abuse

-Mental illness -Domestic violence

-Trauma

-Unemployment

-Victimization -Social environment

-Gambling

-Negative peers

Four-Filter Process

In compelling circumstances where the health and safety of an individual is believed to be at risk, personal information may be shared between agencies following the "Four Filter Process":

Filter 1 - An agency screens a situation of acutely elevated risk and determines it will require a collaborative multi-disciplinary approach beyond the services they can offer to effectively mitigate risk.

Filter 2 - The situation is presented by the agency in a de-identified, anonymous format relevant agencies. Each agency to representative must agree the situation meets the level of acutely elevated risk before moving to Filter 3.

Filter 3 - From the de-identified information. agency representatives decide which agency will lead the intervention at Filter 4, and which agencies will assist.

Filter 4 - The identified agencies will meet privately and disclose a limited amount of personal information necessary to develop an intervention plan. Any information disclosed will be in compliance with Ontario privacy legislation. An intervention plan with customized service will be developed for the purpose of stabilizing the situation.

Written notification will be provided to the individual whose personal information was shared in accordance with Ontario privacy legislation(s) FIPPA s. 41(1)(h), MFIPPAs. 32(h)and PHIPA s.40(1)
