



## **Township of Brock – “Get Moving in Brock” Recreation Photo Contest**

### **Overview**

Introducing, “Get Moving in Brock”, the Township of Brock Recreation Photo Contest to celebrate June as Recreation and Parks Month and our amazing opportunities for recreation in our community. This contest is being held by the Township of Brock from June 1<sup>st</sup>, 2019 to June 30<sup>th</sup>, 2019. Upload any photo you have taken that represent recreation, both organized and individual to social media with the hashtag #GetMovingInBrock and tag @TownshipofBrockSportandRecreation for your chance to win one of 4 weekly prizes. To be entered into the Grand Prize draw, submit your photo online at [www.townshipofbrock.ca/JRPM](http://www.townshipofbrock.ca/JRPM).

### **Eligibility**

This contest is open to any resident of Brock Township during the period of June 1<sup>st</sup>, 2019 and June 30<sup>th</sup>, 2019. Odds of winning depend on the number of entries received. Each entrant under the age of thirteen (13) must have the consent of his/her parent or legal guardian to submit his/her personal information and enter the Contest. The parent or legal guardian must complete all required fields of the relevant portion of the entry form, including his/her name and contact information. If a parent or legal guardian does not provide consent, the entry will be disqualified.

### **How to Enter**

From June 1<sup>st</sup>, 2019 to June 30<sup>th</sup>, 2019, take a photo that the represents the recreation opportunities in Brock and upload it to [www.townshipofbrock.ca/JRPM](http://www.townshipofbrock.ca/JRPM) to be entered in the Grand Prize Draw. Photos uploaded to Social Media will be entered in the weekly draws.

All photos submitted online will be entered in a draw for the grand prize.

The Township of Brock reserves the right not to post any content deemed inappropriate by the Township of Brock in its sole discretion.

### **Prizes**

Weekly prizes will be awarded for the contest duration on each Friday in June. Each week we will submit social media entries into a draw for a Free Fitness Class Pass.

The Grand Prize winner under the age of 13 will receive a free week of camp. Entrants over the age of 13 will receive free fitness classes for the year.

Value of prizes varies. No equivalent cash prizes will be awarded.

## **Winning Notification**

All monthly prize winners will be notified by email and their photograph will be featured on [www.townshipofbrock.ca](http://www.townshipofbrock.ca) for the week. The Two grand prize winners will be announced on July 1, 2019. Winners will have 15 days to claim their prize from the Township of Brock Municipal Office.

## **Release of Liability / Privacy & Consent to Publicity**

## Conduct
